Procedures for access to the medical file

The medical file is a confidential document kept in the Medical Records Department. Medical Archivists ensure the disclosure of health information in accordance with the current laws and regulations in Quebec.

Request for access to information

Subject to certain exceptions under the Act: "a user's record is confidential and no one can access it except with the consent of the user or the person who can give consent on his or her behalf ... " (Act respecting health services and social services, article 19)

In order to obtain a copy of a medical file, you must make a written request. This application can be sent by mail, fax, email (archives. medicales@muhc.mcgill.ca) or you can fill out the form in person during the business hours of the hospital's Access to Health Information Office where you received health care.

Please include the following information on your application so that it can be answered appropriately:

□ Last name and first name of the patient
□ Date of birth
□ Hospital card number of the patient according to site
□ Health insurance card number
□ Your complete contact information (name, address, telephone number)
□ The information required and the period covered
□ Last name and first name of the document recipient
□ Address of the recipient
□ Date and signature of the patient or the authorized person

Who must sign the request?

Patients under 14 years of age: The application must be signed by a parent or legal guardian.

Patients 14 years and over: The application must be signed by the patient or legal guardian or mandatary.

(Act respecting health services and social services, article 19)

Transmission delay

According to the Act respecting health services and social services, article 24: The institution must respond to a request for access as soon as possible.

Fees

In accordance with the regulation respecting fees for the transcription, reproduction and transmission of documents and personal information, fees may be charged depending on the type of application and the number of documents desired by the patient/legal guardian/mandatary. The fee is available upon request from the Medical Records Service.

Frequently Asked Questions

Can I consult my file?

Yes, you must make a written request and a Medical Archivist will contact you to give you an appointment. (Act respecting health services and social services, article 25)

Why is there a delay in accessing my file?

We receive a large number of requests, be rest assured that we will reply within a reasonable time. However, if a case is urgent, any physician who has obtained the written authorization of the patient or his legal representative can contact the Medical Records Services and the information will be transmitted to the physician.

Are there any restrictions on access to my file?

Yes, there may be restrictions.

Serious prejudice

Access to your file or part of the file may be withheld if your physician is of the opinion that disclosure of this information could cause serious harm to your health. However, this restriction is temporary. (Act respecting health services and social services, article 17)

Third party information

Several laws protect the information provided by third parties and concerning third parties mentioned in the health records (Act respecting health services and social services, article 18 and Act respecting Access to documents of public bodies and the protection of personal information, article 88)

Where can I get images of my x-rays, tomography, etc.?

Medical Records Services provides only written reports of medical imaging.

Can I request a rectification of my information?

Any person may make a request for correction of inaccurate, incomplete or equivocal information. (Act respecting Access to documents of public bodies and the protection of personal information, article 89)

Can I obtain the time of my birth?

An attestation of the time of your birth may be given to you; however a fee payable in advance is required.

Can I access my child's medical record?

Parents can have access to their child's medical records if they are under 14 years of age.

As of the age of 14, a child may have access to his or her own medical records. In order for another person to have access to it, the child must give his or her written consent. (Act respecting health services and social services, article 21)

Can I access the file of a deceased family member?

The file of a deceased person remains confidential even after their death. The Act respecting health services and social services, article 23, provides certain procedures for accessing the files of deceased persons.

Do I have a right of appeal?

Yes, you have a right of appeal to the Access to Information Commission. The appeal must be filed within 30 days of the refusal of the application or the expiry of the deadline for replying. (Act respecting Access to documents of public bodies and the protection of personal information, article 135)

If adopted, how can I find the name of my biological parents?

How do I obtain a birth or death certificate?

You can obtain these certificates from the Director of Civil Status **etatcivil.gouv.qc.ca** However, MUHC hospitals can provide you with an attestation of birth or death.
